Do not use hot water. After product is mixed, use the liquid within 48 hours.</p> <p><b>Application:</b> Apply liberally to wood surfaces with a TWP® pump sprayer or a synthetic bristle brush. Always test a small hidden area to see if the desired result will be achieved. Wood Brightener Plus should sit for a minimum of 10 minutes. Do not allow product to dry on surface. After dwell time you may begin to scrub (no scrubbing necessary with use of pressure washer). When scrubbing applied area, use synthetic, stiff bristle brush (do not use a wire or natural bristle brush. Rinse thoroughly with hose or pressure washer. A pressure washer will show the best results, however, do not exceed 1000 PSI. If stubborn areas remain, repeat application process.</p> <p><b>Caution:</b> If not used properly, a pressure washer may damage wood. This product contains Sodium Percarbonate. <b>KEEP OUT OF REACH OF CHILDREN!</b> Use caution after mixing, contents are under pressure.
